A Letter from Father M. Favero to the Knights of Columbus Council 7991.

Greetings Gentlemen Knights,

This is a short autobiography to introduce myself to you as Knights. Firstly, some of you will remember me from when I was first here at Ascension from 1998 to 2003 and now I am back here fifteen years later. It is not too often that as priests we return to a Parish where we were previously assigned. As I had mentioned the first weekend that I was here at the beginning of August, it felt like I was coming back home which is a positive feeling I would say.

To give some background. I am the oldest of six children with my parents both living in Comox along with a sister who is next door. I grew up in Vancouver attending St. Patrick's school for two years and Vancouver College for ten years. I thought I had a vocation while in Elementary school and years later in high school the principal suggested if the vocation was still there after high school to pursue it. I worked at Safeway for a few years and later as a cook in restaurants and while living in Comox inquired at the Parish for a vocation to the priesthood. My education then started with a University degree from St. Thomas Moore College at the U. of Saskatchewan and a Masters of Divinity degree from Newman College in Edmonton.

Since my ordination in June 1992 I have served in Campbell River for a couple of years as an Assistant, four years as a pastor in the North Island Parishes then here at Ascension for five and a half years. Next, I was at Holy Cross Parish in Saanich for three years followed by some time off and a sabbatical year. I then came back to St. Rose of Lima at Sooke, B.C. for seven years and for the past two years at Fort Nelson as a missionary in the diocese of Whitehorse. I look forward to meeting the members of the Council and all the work that you do in the Parish and the wider Oceanside community.

Pope Francis has ordered a Belgian Catholic charity to stop offering euthanasia in its psychiatric hospitals. The Brothers of Charity group had previously announced it would allow doctors to perform euthanasia at its 15 psychiatric hospitals in Belgium. The Catholic Church opposes euthanasia and the Holy See has began investigating the decision to allow the procedure, which was made by the group's lay board of directors.

News of the New Fourth Degree Uniform.



In early August 2017 the KofC board of directors voted to adopt a new uniform for the Fourth Degree. The decision was made with the good of the entire Order in mind. Several factors led the board to reach this decision. The Ceremonial swords will continue to be part of the Fourth Degree along with gloves. Colored patches will be worn on the beret behind the 4th Degree emblem to identify the different rankings. The old uniforms may continue to be worn until the end of the current fraternal year (June 30, 2018). The change was decided by the board of directors after a three year period of testing and discussion. It had previously been discussed with the vice supreme masters at the Supreme Assembly. To the question of members input it was noted that "for years supreme officers and directors received comments from members and prospective members that the old regalia was a barrier to membership overall, or to membership in the Fourth Degree. Bringing the change to better understanding the KofC stated "During the

convention, the Good of the Order Committee stated, "We commend all of the faithful Sir Knights who have proudly worn the Fourth Degree regalia, bringing much respect to the Order. With the new Fourth Degree uniform, recently approved by the Board of Directors, this honor and respect associated with Sir Knights will remain, and it will open the door more widely for a new generation to join their ranks. In the spirit of unity, let us assist with a smooth transition to this new uniform and encourage it to be worn with great dignity and pride."

Catholic groups are mobilizing to help in Hurricane Harvey's aftermath.

Catholic dioceses and charities are quickly organizing to help in the aftermath of a Cat 4 hurricane that made landfall with heavy rains and 130 MPH winds on Aug 25th in Texas. The National Weather Service estimate the expected rainfall after the hurricane and storm are over "are beyond anything experiences before". 135th Supreme Convention St. Louis - Aug 17'

More than 2,000 Knights and their families gathered in St. Louis for the Convention. OPEN FORUM;

FROM THE NATIONAL FRONT;

A new bill before the House of Commons has triggered religious freedom concerns because it removes Criminal Code of Canada(CCC) sanctions against disrupting or obstructing worship services. Bill C.51 would remove section 176(1) of the CCC that protects clergy from being obstructed by force or threats from conducting worship services, and applies sanctions against those who would disrupt or obstruct worship services. As commented by Conservative MP Cathay Wagantall who said the Gov't is sending a mixed message when it comes to religious freedom and on June 15 told the House of Commons, "The Liberals were very supportive of Motion No.103, which protects Muslims from an undefined term, 'Islamophobia', yet, Bill C.51 proposes to remove the only provision in the Criminal Code that protects all religious communities and all religious officials". The Canadian Human Rights Act has been amended with the addition of gender identity and gender expression to the list of prohibited grounds of discrimination. On June 19, royal assent was given to Bill C.16 and it is now law. The Catholic Civil Rights League (CCRL) feels these amendments will no doubt serve as guidance for human rights commissions and tribunals along with other governing bodies to decide against those who believe that the two genders are Male and Female. Cardinal Fernando Filoni in his book "The Church in Iraq" comments, 'to understand the current situation in Iraq, the evolving and complex conflicts there, one has to understand its past which is often ignored or unknown in the West. The book is 'a testimonial ' to the victims of the 'Islamic terrorism of ISIS' he told the Christians and non-Christians he met when Pope Francis sent him as his personal representative to encounter and pray with these shaken communities that fled the Islamic State. The Italian cardinal lived in Irag during a time of great tension and turmoil. St. John Paul II made him the apostolic nuncio to Iraq and Jordan in Jan 2001. St. JPII firmly opposed military intervention and, despite the fact that he sent peace-seeking missions to Washington and Bagdad, the United States attacked. Not even the stern warning of the St. Pope could deter Pres. George W. Bush, the cardinal wrote. In his book, Cardinal Filoni speaks to the daily contact between Christians and their Muslim

neighbors which led to a sharing of ideas. He recalls when he lived in Bagdad, he visited a church dedicated to Mary in a predominantly Muslim neighborhood. "I was astounded by the fact that the walls of this church were dirty" with what looked like handprints smudged everywhere he said. When he asked Church members, "Why don't you clean this? They said "No! Because these are the signs of the Muslim women who come to pray to Mary, mother of Jesus, and as a sign of their prayer, they leave an imprint of their hand." Since Mary is revered by Muslims, he said many expectant mothers visit this church to pray to her for protection. (Vatican CNS July 14, 17').
