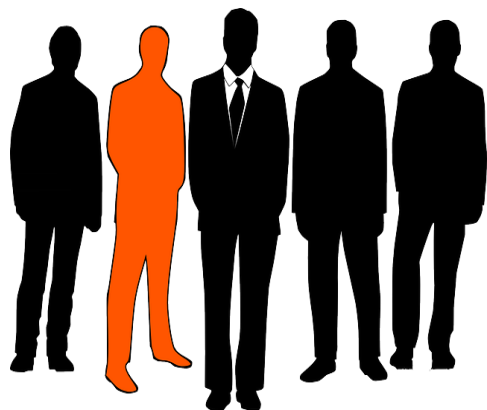

Effective Jan 25, 2016, six Mission Dioceses will no longer be under the Roman Curia. The Archdiocese of Keewatin - Le Pas, Grouard-McLennan, Churchill- Hudson Bay, Moosonee, MacKenzie -Fort Smith, Whitehorse, have been transferred to the competency of the Congregation for Bishops and will pass over to the jurisdiction of the Common Law of the Church. Here's a hint if you're travelling and will be away from home for several days or weeks.

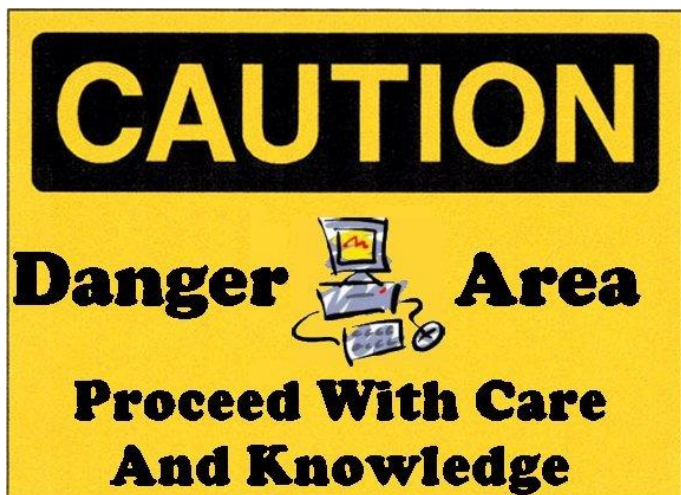
-You may notice you digital clocks flashing which indicates there has been a power outage during your absence. But, it's difficult to know when it occurred or how long it lasted, therefore impossible to tell how long the food in your freezer may have thawed, was destroyed, then froze again.

Here's a helpful hint; all you need is a cup, a coin and some tap water; **Put a cup of water in the freezer, let it freeze solid then put a coin(quarter) on top and leave it in the freezer.** That way, if the coin fell to the bottom of the cup, it means the food defrosted and should be discarded. But, if the coin is either on top or in the middle of the container your food might still be OK. Thus, **BE SAFE!**

From the Catholic Civil Rights League; Toronto, Nov. 2, 16', reports the BC Court of Appeals unanimous decision 5-0 in favour of Trinity Western University in its struggle against the BC Law Society. The Law Society had revoked the accreditation of the TWU School of Law after complaints by members of TWU unlawfully discriminating against the LBGTQ community. The Catholic Civil Rights League intervened in the case alongside the Faith and Freedom Alliance and the BC Archdiocese of Vancouver.

Quoting the CCRL report of Nov. 2nd, 16', the Court provided a summary of its ruling which may be a worthwhile passage. "(193) A society that does not admit of and accomodate differences cannot be a free and democratic society - one in which its citizens are free to think, to disagree, to debate and to challenge the accepted view without fear of reprisal. This case demonstrates that a well-intentioned majority acting in the name of tolerance and liberalism, can, if unchecked, impose its views on the minority that is in itself intolerant and illiberal."
